

# 2020 Winter Percussion Parent & Student Contract

I understand that \_\_\_\_\_ has been accepted as a member of Sultana's Winter Drumline for the 2020 competitive season. I understand that each Member is held to high academic and behavior standards, and is expected to demonstrate a high level of commitment, dedication and hard work toward the team at all times.

I understand that all rehearsals, camps, competitions, and other performances as listed below are mandatory for the success of the Ensemble. Only a doctor's note or a serious and compelling reason, as determined by the Band Director and accompanied by a signed parent note, may excuse the Member from a rehearsal. Unexcused absences will result in a lowered grade and may be grounds for removal from the Drumline.

I understand the financial commitment that comes with being a Member of the Ensemble, listed below, and will pay or fundraise the amounts by the indicated due dates. All payments are non-refundable.

I understand that for any student to remain in Drumline, they must follow all school rules set forth in the Sultana Student Handbook, including the academic standard of a 2.0 GPA and passing a minimum of 4 classes with a D or better, as well as the standards of the Band Director and Percussion Instructor.

I understand that proper safety precautions and protection must be taken by each Member during and outside of rehearsals and performances to remain in a physical condition that allows them to rehearse, travel and perform with the group for the length of the season, as appropriate to their section.

I understand that any unexcused absences from rehearsals, inappropriate behavior, poor attitude or insubordination at any time, or any other breach of this contract, may be cause for suspension/removal from the Drumline without refund.

In signing this contract, I am giving my child permission and acknowledging their commitment to attend ALL Winter Percussion rehearsals, day camps, and competitions found on the attached "2020 Winter Drumline Season Schedule".
